ECHO –Kate Moore & Matthew Mollica

- Late last night HUD signed the mega waiver that is going to loosen restrictions on CoC Funds that comes in from HUD
- Going to change how HUD funds can be used and what is reported on the next couple months
- ECHO will be reviewing document in detail and will set up call with partners to talk through implementation locally
- Thank you for completing survey monkey
 - Working today on summarizing and putting that information together and want to report out to this group and the city on what we heard back from partners - we really appreciate everyone taking the time to think this through and provide feedback during this very busy time
- Propose change to call schedule
 - Reduce to having calls 3 days a week Monday Wednesday Friday. This schedule will allow for the people providing report outs to plan between calls.
- Schedule will begin this week with no call on Thursday and will have a call on Friday.
- Defer to City to provide more details on the scope and operations of the soft launch of how the referral process will go from providers people experiencing homelessness into a Q/I Unit

COA/APH - Chris Shorter

- Current number for COVID cases: 25 people experiencing homelessness were moved to two different isolation facilities
- City of Austin is continuing to grow and unlock additional hotel rooms
- Going to leverage pre-screen tool with emergency shelters ARCH/Salvation Army today
- Hoping that a hotel will be online this afternoon and with that start the use of the nursing hotline for those providers - SOFT Launch
- Soft launch is important nurse line hasn't been a line to receive 100s of calls. We want to be sure that capacity is built as the number of calls and cases increase
- Robert Kingham has been pulling together DACC team and case management staff to support hotline and assigning units Bed management team
- Using isolation units strictly for those who are symptomatic or waiting testing or confirmed positive and recovering

 - Green light to move forward with programs around food access and working with 3rd party vendor called revolution foods (outlines in memo from City on Friday)

Healthcare System – Dr. Tim Mercer

- Screening is happening but there needs to be more testing happening.
- Concern expressed surrounding who is completing clinical assessment of the current cohort who is
 entering the isolation and quarantine units and ensuring they have the medications and tests needed for
 services and treatment.
- Priority needs to be with supporting the downtown shelter population. Congregate settings are more atrisk for possible outbreaks

Integral Care Updates

- All in person services will be consolidated into one location at East 2nd Street Clinic
- PES has transitioned to telehealth interventions and MAT programs remain open
- Want to provide harm reduction into hotels
- Great concern for harm reduction and SUD for people experiencing homelessness being placed. Call number 512-472-HELP
