

- 774 COVID-19 cases in Travis County. There have been 9 deaths and 140 people have recovered
- No update on number of people experiencing homelessness who have tested positive. 2 people have has recovered
- Pro-Lodge 2 opening today
 - o 60 guest capacity
- Austin City Council approved allocating \$15 million from their emergency reserve fund, RISE (Relief in a State of Emergency)
 - Funding will go towards improving food access, case management, and assistance with rent/mortgage, utilities, and medical and childcare expenses

- Food access
 - Distributing prepared meals starting tomorrow (4/14/20)

 - Working with food access team to distribute educational materials
- DACC
 - o Continues to offer walk in case management triage services, 8am 5pm Monday Friday
 - 347 people served since March 16th, averaging 17 people a day
 - DACC helps organize the Austin Homelessness Advisory Council (AHAC)
 - AHAC is a group of people with lived experience of homelessness that is available to provide input/feedback via surveys on policies and services
 - Today, 4/13/20, group will be collecting feedback on the City's communications efforts around COVID-19
 - is providing periodic feedback via surveys
 - Other agencies can request feedback from AHAC at upcoming meetings (4/27/20 and 5/11/20)

 - L Williams will help draft surveys which consist of 8-10 open-ended questions
 - 2-week turnaround time to receive feedback

 - This entails testing individuals (clients and staff) who are not symptomatic or reporting symptoms to proactively identify cases
 - No additional positive test results have been found
 - CommunityCare back at The ARCH today with around 100 COVID-19 tests to expand this initiative by testing as many clients staying at The ARCH as possible
