


Population Characteristics

KEY TAKEAWAY:


A Black Austinite is still six times more likely to experience homelessness than a white Austinite

Population Characteristics: Households




INTERSECTIONS:

- Families with children are more likely to be Hispanic/Latinx or Black
- Single men comprise the largest demographic group in the population

Connecting People to Services

KEY TAKEAWAY:

Collaborative outreach efforts are connecting more people to housing assessments and crisis services faster

50% decrease in wait time for first time Coordinated Assessments




55% increase in the number of street outreach projects in the system




55% increase in the number of people getting first time

Number of Enrollments by Project Type




Increased Need

KEY TAKEAWAY:

Our system can't provide everyone the support they needs in housing because we don't have nearly enough places for people to stay long-term

Moving Clients Into Units



- Our system
 housed more
 people in 2022
 than ever before
- We need to be able to house more people to keep up with inflow to homelessness, requiring more units

GAPS IN MEETING POPULATION NEEDS

- Despite our system's ability to connect more quickly than before with people who need places to live, finding units to house people in is a different story...
 - Our system's ability to rehouse people who want and need a more involved intervention is dependent on the number of units in our HRS.
 - Because the vast majority of units providers have access to are rented through the private market, a tight housing market makes finding a place to live much harder, even with rental assistance and a case manager.

GAPS IN MEETING POPULATION NEEDS

- A person living in Austin needs to make \$77,640 in net annual income to reasonably afford an average Austin apartment
- As Austin's housing market becomes increasingly unaffordable, the effects fall disproportionately on Black and Hispanic communities
 - Black and Hispanic Austinites more likely to be in low-income households
 - New residents moving to the Austin area are disproportionately white, driving gentrification in historically Black and/or Hispanic neighborhoods

FILLING IN THE GAPS...

- Our community needs to continue growing our supply of PSH
 - We have thousands more people who qualify for PSH than we have units available to house them in
 - NOTE: Austin has a very high chronic homelessness rate relative to other cities, and PSH is usually the best fit intervention type for chronically homeless households
- Our system also needs to keep up with the need for RRH, as ARPA funding comes to a close
